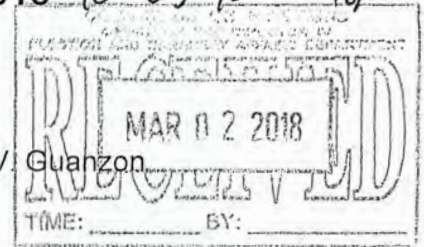

January 25, 2018, deleting the text box "Senior Citizen" in the upper right portion of Part 1 (Personal Information) in the approved new template of application form.


Let the Election and Barangay Affairs Department implement this Resolution.
