RESOLUTION NO. 9278

WHEREAS, on September 30, 2010, the Commission on Elections promulgated Resolution No. 9046 entitled "Preservation of the Book of Voters and other Election Documents used in the May 10, 2010 Automated National and Local Elections in compliance with the Precautionary Protection Order issued by the Presidential Electoral Tribunal in PET Case No. 004, *Manuel A. Roxas vs. Jejomar C. Binay*";

WHEREAS, in Resolution No. 9149 dated February 22, 2011, the Commission promulgated Rules and Regulations for the Resumption of the System of Continuing Registration of Voters and Validation of Registration Records in the Non-ARMM areas;

WHEREAS, Section 11 of Resolution No. 9149, details the procedures for the filing of application for transfer of registration records from other district/city/municipality. Part of the process is the sending of the registration records of the approved application for transfer by the Election Registration Board from the Election Officer of origin to the Election Officer of applicant's new residence;

WHEREAS, the Voter's Registration Records (VRRs) are compiled/stored in the Book of Voters as mandated in Republic Act No. 8189 otherwise known as "Voter's Registration Act of 1996";

NOW THEREFORE, pursuant to the powers vested in it by the Constitution, the Omnibus Election Code, Republic Act No. 8189 and other related election laws, the Commission on Elections has **RESOLVED**, as it hereby **RESOLVES**, to apply the precautionary measures itemized in Resolution No. 9046 in connection with the ongoing registration of voters, to wit:

- 1) Keep the Books of Voters used in the May 10, 2010 Automated National and Local Elections intact in the Offices of the Election Officers until further Orders by the proper court or tribunal;
- 2) Applications for registration, transfer of registration record, reactivation, and change of name/correction of entries/reinstatement of name/inclusion of registration record of voters for the Barangay Elections approved by the ERB during the July 18, 2011 hearing and thereafter, shall in the meantime be compiled in separate folders and arranged by precincts. If the said ERB newly approved applications have already been included in the Book of Voters, the


same shall be removed from the Books of Voters and compiled in separate folders; and,

- 3) Preserve the PCVLs, EDCVLs, other election documents and paraphernalia used in the May 10, 2010 Automated National and Local Elections.

Further, if the concerned VRR was used in the May 10, 2010 elections, the provision on sending the VRRs of the approved application for transfer to the Election Officer of the applicant's new residence as stated in Section 11 of Resolution No. 9149 shall be held in abeyance.

Let the Election and Barangay Affairs Department implement this Resolution.
