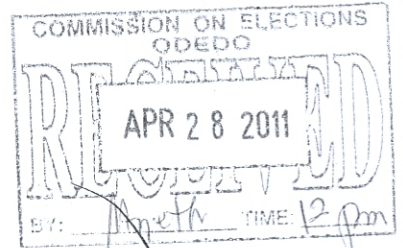

RESOLUTION NO. 9211

**WHEREAS**, on April 19, 2011, the Commission on Elections promulgated Resolution No. 9198 prescribing, among others, the periods for the filing of certificates of candidacy, and the holding of political conventions to select and nominate official party candidates in connection with the August 08, 2011 election of regional officials in the ARMM;


**WHEREAS**, to ensure completion of the preparatory activities prior to the filing of certificates of candidacy, there is need to reset the periods for the filing of certificates of candidacy, and the holding of political conventions to select and nominate official party candidates in connection with the August 08, 2011 election of regional officials in the ARMM;

**NOW, THEREFORE**, pursuant to the powers vested in it by the Constitution of the Republic of the Philippines, the Omnibus Election Code (BP Blg. 881), Republic Acts No. 8189, 9333, 9369, and other election laws, the Commission on Elections has resolved to reset: (1) the period for the filing of certificates of candidacy for the August 08, 2011 election of regional officials in the ARMM to May 14-18, 2011; and (2) the period for the holding of political conventions to select and nominate official party candidates for the August 08, 2011 election of regional officials in the ARMM, to not later than May 18, 2011.


This Resolution shall take effect seven (7) days after its publication in two (2) daily newspapers of general circulation the Philippines. The Education and Information Department of the Commission on Elections shall cause the immediate publication of this Resolution and furnish copies thereof to all concerned.


