RESOLUTION NO. 9219

WHEREAS, on April 19, 2011, the Commission on Elections promulgated Resolution No. 9198 prescribing, among others, that the election period for the election of regional officials in the ARMM is from May 10, 2011 to September 07, 2011;

WHEREAS, in the same Resolution, the Commission on Elections also fixed the period of May 10, 2011 to August 07, 2011 as the period for the prohibition on the appointment, creation or filling up of new positions, promotions or giving of salary increases or remuneration or privilege, release, disbursement or expenditures of public funds, and construction of public works;

WHEREAS, there is need to reset the aforementioned periods to afford more time to prepare and review the guidelines for the conduct of the elections to ensure a credible election in the ARMM;

NOW, THEREFORE, pursuant to the powers vested in it by the Constitution of the Republic of the Philippines, the Omnibus Election Code (BP Blg. 881), Republic Acts No. 8189, 9333, 9369, and other election laws, the Commission on Elections has resolved to reset: (1) the election period to **June 09, 2011 to September 07, 2011**; and (2) the period for the prohibition on the appointment, creation or filling up of new positions, promotions or giving of salary increases or remuneration or privilege, release, disbursement or expenditures of public funds, and construction of public works, to **June 24, 2011 to August 07, 2011**;

This Resolution shall take effect seven (7) days after its publication in two (2) daily newspapers of general circulation the Philippines. The Education and Information Department of the Commission on Elections shall cause the immediate publication of this Resolution and furnish copies thereof to all concerned.


