RESOLUTION NO. 9701

WHEREAS, to aid the boards of canvassers in the conduct of their respective canvassing and consolidation of votes, Resolution No. 9648 (General Instructions for the Boards of Canvassers on the Consolidation/Canvass and Transmission of Votes in Connection with the May 13, 2013 National and Local Elections) dated February 22, 2013, provides for the following methods of monitoring of election results, namely:

1. Section 28 (c) - on the procedures that will enable the city and provincial boards of canvassers to monitor which results have been received by the CCS either by electronic transmission or manual uploading; and

2. Section 28 (f) (1) – on the procedures for the Generation and Printing of Grouped Canvass Reports, which will enable said city and provincial boards of canvassers to view the votes of all candidates, by position, which have been received by their respective canvassing and consolidation system (CCS), and to generate and print said report;

WHEREAS, in connection with the canvass of votes by the Commission En Banc sitting as the National Board of Canvassers (NBOC) for Senator, there is a need to monitor the results to be transmitted to it by the different provincial boards of canvassers, and city boards of canvassers whose certificates of canvass shall be directly submitted to the NBOC for canvass;

NOW, THEREFORE, pursuant to the powers vested in it by the Constitution, the Omnibus Election Code, Republic Act No. 7166 and other election laws, the Commission on Elections RESOLVED, as it hereby RESOLVES, to direct the Provincial Boards of Canvassers, and the City Boards of Canvassers whose certificates of canvass shall be directly submitted to the NBOC, who have not yet transmitted their respective Certificates of Canvass to the National Board of Canvassers as of 5:00 o'clock in the afternoon of May 15, 2013, as follows:

1. To generate and print the "Grouped Canvass Report" for all candidates running for the position of Senator. The chairman and members of the board of canvassers shall affix their signatures over their printed names, and require the watchers, if present, to also affix their signatures over their printed names;

In case a Grouped Canvass Report cannot be generated due to the failure of the CCS to receive at least 70% of the election returns (in the case of city board of canvassers), and certificates of canvass (in the case of provincial boards of canvassers), which the CCS expects to receive, to generate the "Monitor Results Transmission" Report for all candidates running for the position of Senator by precinct (in the case of city boards of canvassers) and by municipality (in the case of provincial boards of canvassers), and to print said report by observing the following procedures:
 - Click name of the municipality that has already transmitted its Municipal Certificate of Canvass, indicated by the green light beside the municipality name;
 - ii. Click election returns number, indicated by N° on the left column beside the contest (Senator);
 - iii. Go to the bottom of the screen and click Print button;
 - iv. Follow same procedure for the next municipality, in case of the provincial board of canvassers, and for the next precinct, in case of the city board of canvassers;

The chairman and members of the board of canvassers shall likewise affix their signatures, and those of the watchers, if present, over their printed names on each and every page of the report;

Let the Supervisory Committee of the National Board of Canvassers implement this Resolution.
