RESOLUTION No. 9769

WHEREAS, on 18 June 2013 the Commission on Elections promulgated Resolution No. 9715, entitled "*Calendar Of Activities And Periods Of Certain Prohibited Acts In Connection With The October 28, 2013 Synchronized Barangay And Sangguniang Kabataan (SK) Elections*".

WHEREAS, in the above Resolution the period for the prohibition on the issuance of appointments, creation of new position, promotion, or giving of salary increases is from September 28, 2013 to November 12, 2013 (Election Period), when the period for said prohibitions should be only up to October 28, 2013 (Election Day).

NOW, THEREFORE, the Commission on Elections **RESOLVED**, as it hereby **RESOLVES** to amend Resolution No. 9715, entitled "*Calendar Of Activities And Periods Of Certain Prohibited Acts In Connection With The October 28, 2013 Synchronized Barangay And Sangguniang Kabataan (SK) Elections*" by providing that the period for the prohibition on the issuance of appointments, promotions, creation of new positions, or giving of salary increases is from **September 28, 2013 to October 28, 2013**.

This Resolution shall take effect on the seventh (7th) day after its publication in two (2) daily newspapers of general circulation in the Philippines.

The Education and Information Department shall cause the publication of this Resolution in at least two (2) daily newspapers of general circulation in the Philippines.

The Deputy Executive Director for Operations shall implement this Resolution.
